

Q&A WITH HEATHER GAGEN

Could you provide an insight into how you approach your work? What drives and motivates you?

a highly strategic mind, a great deal of emotional intelligence and a strong sense of humour.

Reflecting on your area of expertise, how do you see this sphere of the market shaping up over the coming months? Are any exciting trends or developments on the horizon?

◆ Businesses are navigating an incoming wave of ESG regulation that brings mandatory disclosure and due diligence requirements. At the same time, they are facing the commercial pressures of political and economic instability globally which can make it difficult to develop and implement long-term strategies around ESG. This means that boardroom focus on ESG will inevitably increase, but businesses will want to take a variety of approaches – depending on their geographic footprint, sector and commercial ambitions. They will need to decide if they will see ESG through a compliance lens, or whether they want to use the regulatory framework as a springboard to achieve more ambitious sustainability goals. I also expect the trend to continue of businesses being held to account, whether by regulators, in court or the media, for their record on ESG. They must have this front of mind in developing their strategy and approach to sustainability. ■
